Three sessions were held to compare the learning outcomes of participants who received training remotely in the MTU versus those who received the same training face-to-face. To minimize variables affecting study outcomes, face-to-face training sessions also took place in the MTU space. A control group (i.e. received no training) was included to show that the intervention group (i.e. remote) was not inferior to the comparison group (i.e. face-to-face), and that both instructional approaches are actually effective "
